# 3. Approval of September 6, 2012 minutes

A motion was made by Werner Oyanadel and seconded by Chris Sedelmaeir to approve the minutes from the meeting of September 6, 2012 and were approved by a unanimous voice vote.

# 4. Police Survey Update

Ken Barone provided an update on the survey that was designed for Police Agencies throughout the state to benchmark current traffic stop data collection system. The survey has been distributed to agencies and we expect preliminary information to be available in November.

## 5. CJIS Data Application Presentation

Sean Thakkar, Executive Director of CJIS provided a brief presentation to the advisory board. The presentation was a sample of how CJIS plans to present traffic stop data in live time as information is extracted from each police agency.

#### 6. New Business

## a. Data Elements report- Jim Fazzalaro

Jim Fazzalaro presented the advisory a detailed summary of the data elements being considered by the working group to be added to the list of elements already outlined in the law. There was some discussion on each data element and the advisory board was informed that this was a work in progress. The work groups were tasked with addressing the post-stop data elements in their October meetings.

### b. Post-Stop Data report- Ken Barone

Ken Barone provided a summary report of post-stop data elements that the advisory board is considering. The summary report included information about other states that analyze traffic stop data using post-stop information. A discussion took place about the importance of looking into post-stop data elements and it was determined that the project staff would conduct a joint work group meeting to look at each data element individually.
