I. Welcome & Introductions

Gail Hardy convened the meeting at 10:06 a.m. and asked members to introduce themselves.

II. Approval of the November 30, 2022 minutes

Chief Fusaro made a motion to approve the November 30, 2022 meeting minutes and it was seconded by Rachel Timm. The minutes were approved by members via voice vote.

III. Old Business

a. CTRP3 Website and NYU Public Dashboard

Guest speaker, Angela Hawkin from NYU's Maron Institute provided background on the institute's impact and practices to ensure data is used to inform change. They intend to make certain data is transparent and available to the public. Ken Barone briefly states to the subcommittee members the relevance of having a public dashboard would initially be viewed by members of the Community Outreach Subcommittee. Over the coming months while the dashboard is being created subcommittee members will provide feedback and advice before presenting it to the full Advisory Board for their input.

Jonathon Kulick gave an overview of the data they received from UConn of several years of statewide traffic stops. Jonathon stated that his team has been working on two different approaches to display the data and are now testing out functionality and the appearance of the dashboard.

Angela Hawkin commented that the dashboard will allow users to view statewide statistics or to narrow them down into a specific location. Ken Barone mentioned that today's presentation is phase 1 of the discussion of how to help people visualize the data Phase 2 of the project will allow police administrators to access additional information. The primary purpose of the public dashboard is to eliminate the delay for police departments to track their own data.

IV. General Discussion

- a. Public Outreach Activities
 - i. Public forums or event

Chairwoman Hardy opened the discussion for members to discuss methods for engaging with the community. Ken recommended that we hire an outside person to help coordinate public forums and events. The subcommittee agreed with this recommendation.

Ken Barone asked members to visit [National Initiative for Building Community Trust and Justice](#) and read the program description for additional ideas on engaging with the public. In particular, he is interested in feedback regarding the reconciliation training outlined on the website.

- ii. Information sharing through DMV.

Ken mentioned that the subcommittee would like to engage with DMV about whether or not there is information about the law or this project that could be included in registration renewal or license renewal. Gail Hardy mentions that the DMV has a new commissioner and states she has several contacts that she could reach out to either attend the meeting or point her in the right direction of whom to contact.

There was no further discussion and the meeting was adjourned at 11:00 a.m.
